

**NORTH RIDGEVILLE MUNICIPAL COUNCIL
MINUTES OF
REGULAR MEETING MARCH 1, 2010**

CALL TO ORDER: 7:31 P.M.

President Corcoran: I call to order the North Ridgeville City Council Meeting of Monday, March 1, 2010. Please stand for the invocation and pledge of allegiance.

INVOCATION: lead by President Corcoran.

PLEDGE OF ALLEGIANCE: lead by Boy Scout Troop 153.

LOBBY:

President Corcoran: We come to the lobby session of City Council. This is your opportunity to speak to us and let us know what is on your mind. There are certain rules you need to follow. One being that you have three minutes to speak. When you come up to the microphone, please

give your name and address so, if there is any reason for us to contact you, we can do so. You are limited to one subject per night. So, tonight, please stick to one topic. The lobby is now open.

1) Becky Campbell of 5425 Olive Street explained that she is a member of Friends of the Park as well as a Charter member of the Dog Park Committee. On behalf of those committees, she provided a presentation regarding the need for 3.5 acres to be set aside for the creation of a dog park. She explained the benefits and the design of this park and stated that the costs are included in the packet that she handed out to the Council Members.

Council Member Boose: Mr. President, just a comment. This group made a similar presentation to the Park and Recreation Commission last week at their monthly meeting. They have been working together for a long time and the Park and Rec Commission approved a motion to recommend that up to three and a half acres be dedicated for a dog park in the City owned property that is north and east of the current library. The exact location is yet to be determined and most likely, Council will want to have the Engineer take a look at that to see what parcel best suits that. I just wanted to give you that background that they have gone through the Park and Recreation Commission.

President Corcoran: Thank you, Mr. Boose. Is there anybody else that would like to speak before Council tonight?

2) John Klembarsky of 9143 Katherine Street spoke regarding the water pressure problem in his development off Reed Road. He explained that a phone call was made to him from his Councilman on December 15 indicating that the project was completed and that they should see a change in their water pressure. He stated that they have not seen a change and the water pressure problem has actually gotten worse. He read some of the comments he received from his neighbors.

Safety-Service Director Armbruster: We will take a look at that tomorrow. The Engineer is not with us tonight but, we will see if we can get a conclusive answer back to you on what is happening with the vault and the things that are going on over there on Lorain and Bagley.

President Corcoran: Anybody else?

3) Robert Gaydash of 9400 Avon Belden Road thanked Teila Lovell in the Building Department for passing along some answers to his concerns from the last meeting. He thanked Council for providing extreme politeness he received during his three minutes of lobby during the last Council meeting. He asked for, either in writing or on public record, an answer regarding his concerns on the safety situation by the Junior High School that he brought up during the last meeting.

President Corcoran: Mr. Mayor?

Mayor Gillock: First, I would like to point out that the young lady that is sitting right here is Teila who is the one that helped you get your information. She did a great job on that and we

appreciate it. We'll look into that other issue. You have brought it up before but, until tonight, we never knew exactly where you were talking about. We'll take a look at it. Thank you.

President Corcoran: Anybody else?

4) Linda Turner of 38158 Pebble Lake Trail spoke of a safety concern regarding lack of a sidewalk on a portion of Otten Road. She stated that the Homeowner's Association told her that if the developer had widened the sidewalk down Otten Road, the City had agreed to put in the portion to connect the sidewalk. That has not been done. She explained her concern as it relates to the safety of the children riding their bikes down the street, people walking their dogs and people pushing baby strollers.

Mayor Gillock: Mr. President, I can answer this question to clear it up a little bit. When Meadow Lakes was built there were no homes on that particular area and therefore there were no sidewalks required. We met with the developer several years ago over the issue of the sidewalks going up Otten. We wanted that sidewalk put in at that time. The sidewalk that he had put in on Otten was a four-foot sidewalk. We wanted a six foot. At that time we reached an agreement with him that if he tore all that out and put in the six-foot sidewalk, we would take responsibility of putting that piece of sidewalk in that you are referring to but, that was dependent upon the City having the money to do it. We have lots of streets in this City that don't have sidewalks. We are aware of the issue; not just there, but throughout the City. Your summation is pretty accurate. We said we will do that, but again, it depends upon our finances. We are doing appropriations right now and it is something we are going to look at it. Whether we can do it or not right now, I can't say. We can't guarantee when it will be done, but we have said at some point; some day, we'll do that and that is the best answer I can give you right now.

President Corcoran: Thank you. Anybody else? Seeing none, we are moving on to the Administrator's reports. Mayor Gillock?

ADMINISTRATORS REPORTS:

A. Mayor:

Mayor Gillock: Thank you, Mr. President. First, I want to thank the scouts for being here tonight and doing a great job on leading the Pledge of Allegiance.

I also want to add my condolences on behalf of the City to Mr. Gil Cornish. Gil was a Councilman who donated about 16 years of his life trying to make North Ridgeville a better place to be. He will be missed. Please keep him in your prayers. I have three things I want to mention this evening.

First, I received our Annual Treasurer's Report for last year. I just wanted to point out a little bit in what the economy has done to the City's investments. In 2006 the interest on our investments

was 1,238,000 dollars. In 2007 it went up a slight amount to 1,400,000 and then in 2008 it dropped almost in half to 758,000. Last year, it was 452,000. We went from a high of almost a million four to about 400,000 losing a million dollars a year in interest. So, the economy is affecting all of us.

I just want to briefly mention a meeting that was held last Thursday at the Ridgefield Recreation Center. I want to thank the Ridgefield Homeowner's Association for allowing us to use that facility. We had a discussion regarding FirstEnergy removing the discounts that they were giving to all electric homes. It has become quite a controversy. There were meetings in Columbus held by Representative Matt Lundy, Senator Grendell, and Senator Patton, who also had been involved in it. We held a meeting here and had over 400 people show up. We had Representative Matt Lundy, representatives from the PUCO, representatives from the Ohio Consumer's Council, and FirstEnergy. Representative Lundy did announce at that meeting that he received a call about fifteen minutes before the meeting from the Governor's office that they had ordered the PUCO and FirstEnergy to revisit the issue; to reinstate the discount immediately and work out a long range plan that would be much more fair and equitable to those homeowners. We are glad to see that being addressed.

The last thing I want to mention is a project that Columbia Gas will be doing in North Ridgeville which is quite similar to our water meter project where we are replacing all the meters so that we can read the meters on computers at City Hall. We are a little bit ahead of them. They are going to be installing automated meter reading equipment on all their gas meters. In most cases you'll simply get a call saying that they will be doing something to your gas meter and when they will be there. The gas people wear uniforms and have labels or name tags and so forth. It won't be an inconvenience or anything to you. You won't even have to be there in most cases. There are some homes that do have gas meters inside. In those cases they will contact you and they will have to get into the home to make that transition. Again, customers will be given advanced information via a post card of when they will be there. They will have a contact number. It does not cost the homeowner anything. Right now they read your meter every other month and they estimate it in the middle month, unless you are on a budget plan. This will allow them to do as we have been doing with the water for years in driving down the street in a vehicle and pickup the reading. So, that is a tremendous improvement for them. They are going to start this month. It will take them a number of years to do their entire territory, but they are starting in North Ridgeville. So, you will see them out there through March and April and should be finished in early June with the whole City. Thank you. That concludes my report.

President Corcoran: Thank you, Mayor. Safety-Service Director Armbruster.

B. Safety-Service Director:

Safety-Service Director Armbruster: Thank you, Mr. President. I would like to report this past week we had an unfortunate accident with one of our large single axle snow plows. As our plow

driver was driving down Wallace, where the power lines go across there, he lost a little bit of where the road was with the blowing snow; he got off the road and the plow actually tipped on its side as it went into the ditch. I'm happy to report that when Dunlap's brought it out with the big wreckers. There was absolutely no damage to the truck. The truck was in the ditch, but yet it was so soft from the mud that there was no damage to it in any way including the mirrors. The driver was actually transported to Fairview and he was later released. The Mayor and I talked to him about lunch time. This happened about 6:30 in the morning. Everything is good. It is a scare that we had, but it is something that brought us all to recognize that it is pretty tough sometimes to plow snow, especially in the big trucks or in any truck that, if you do see a plow truck, please give clearance to it. It is such a big vehicle when they are going down and throwing salt. Respect those plow drivers because they really work hard for us in the City of North Ridgeville and every place. That concludes my report.

Right now, the wheels are in motion to do something about this situation and hopefully, it will be resolved for both the people in Ward 3 and Ward 4 where there are even more electric homes.

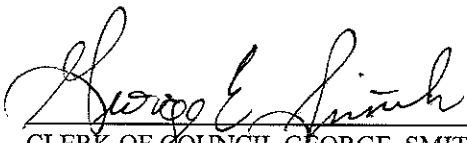
