be given only for the acceptance of the passed agility certificate for both police and fire entrance examination candidates. She explained that the fire agility was held at the beginning of May and that anyone applying after that date would not then have had an opportunity to take it until the next scheduled exam of June 2nd. She stated that regarding the Tri-c police physical agility examination, while the last date was May 19, all slots were taken, and candidates were not able to sign up until the next June 23rd scheduled exam. She explained that the application process would still close on May 27th with all other documentation required by that date but that the extension of the agility certificate submission would afford remaining candidates to take their respective agility examinations and turn in their certificates by the next day and the entire process would be completed prior to the next regularly scheduled Civil Service Commission meeting.

Chairman Schiffbauer commented that if he was hearing her correctly, it wasn't that there were vacancies and people just weren't signing up, it was that the agility slots filled up and we needed more availability.

Deputy Clerk of Council stated that was correct.

Chairman Schiffbauer asked if any member of the Commission had any questions.

None were given.

Moved by Schiffbauer and seconded by Spann to extend the acceptance of the agility certifications for both the police and fire entrance examinations.

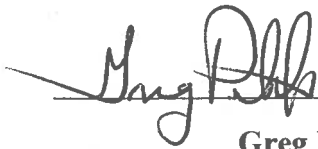
