R 2026-77 PID NO. 116636; PROJECT NAME: D03 SYSSIGN FY2027
A Resolution giving consent and cooperating with the Director of the Ohio Department of Transportation for the overhead sign support improvements on State Route 10.
(Introduced by Mayor Corcoran)

O 2026-78 An Ordinance amending Ordinance No. 2026-39 which imposed a 180-day moratorium on the granting of permits or new business applications for Assisted Living Facilities and Rest Homes in the City of North Ridgeville by extending the moratorium for an additional 180 days, in order to allow the Planning Commission and Council to consider possible changes to Use Regulations in the North Ridgeville Zoning Code.
