

**NORTH RIDGEVILLE CITY COUNCIL
MEETING MINUTES
NOVEMBER 2, 2020**

CALL TO ORDER: 7:30 p.m.

President DeVries called the Monday, November 2, 2020 Council meeting to order.

INVOCATION:

Led by President DeVries.

PLEDGE OF ALLEGIANCE:

ROLL CALL:

Present were Council members President Martin DeVries, Holly A. Swenk, Dennis Boose, President Pro-Tem Bruce Abens, Clifford Winkel, James R. Maleski and Michelle Hung.

Also present was Mayor Kevin Corcoran, Safety-Service Director Jeff Armbruster, Assistant Law Director Toni Morgan, Engineer Dan Rodriguez, Auditor April Wilkerson, Assistant Clerk of Council Tara Peet and Clerk of Council Nancy Linden.

MINUTES - Corrections (if any) and approval:

President DeVries asked if there were any corrections to the City Council meeting minutes of October 19, 2020. No discussion was offered. The minutes stand approved as submitted.

LOBBY:

President DeVries opened the lobby session. He stated they are utilizing Zoom and YouTube for people to type or ask their questions. There are instructions on the City's website through the City Council tab on how to get questions answered at www.nridgeville.org. He paused for comments due to the delay in the broadcast.

He asked Assistant Clerk of Council Peet to read any questions or comments from the YouTube Channel feed. He asked if anyone signed into Zoom wished to speak.

Assistant Clerk of Council Peet stated there were no comments or questions at this time.

ADMINISTRATORS REPORTS:

A. Mayor: Mayor Corcoran requested that City Council consider passing T 119 for the purchase of a Bobcat and a Sewer Cleaner for the Service Department. The reason for the emergency is because these items are built when ordered.

Mayor Corcoran also asked that Council consider passing T 121-2020 with the emergency. It authorizes the City to purchase a wood chipper for the Service Department. A portion of the purchase is being funded through a Community Incentive Grant from the Lorain County Solid Waste Management District. The emergency passage is needed in order to complete the

purchase and close out the grant with the County by December 16 to stay in good standing for future grant applications. The City had to get special permission to apply for the grant as the deadline was in July. Therefore it needs to be completed quickly.

Mayor Corcoran stated tomorrow is Election Day. Polling locations are open from 6:30 a.m. until 7:30 p.m. Visit the Lorain County Board of Elections website at www.voteloraincountyohio.gov and click on polling place lookup for locations.

The holiday food and toy drive for Community Care begins today. Non-perishable food items and new toys in original packaging are needed for Community Care in order to help those families that are less fortunate. Drop off boxes will be located at City Hall and Parks & Recreation. Items can be dropped off at these locations through December 4 and the Parks & Recreation staff will deliver collected items to Community Care.

As a reminder, City Hall offices will be closed on Wednesday, November 11 in observance of Veterans Day.

Mayor Corcoran nominated Donald Schiffbauer to the Civil Service Commission. He is a longtime resident and Chief Executive officer at the Nord Center. He is also involved in many organizations throughout the City including Olde Towne Hall Theatre and North Ridgeville soccer.

Moved by Mayor Corcoran and seconded by DeVries to nominate Donald Schiffbauer to the Civil Service Commission.

B. Safety-Service Director: Safety-Service Director Armbruster stated over the last several months there have been food trucks parked in neighborhoods. It has been difficult for the Fire Department to inspect the trucks. Just recently there was a truck in the Avalon Drive area. It was inspected and found to be safe. The Fire Department needs to determine if there are propane tanks and if they are safe or not.

Safety-Service Director Armbruster stated the ones and twos are placed near St. Peter's Church. There has been dirt moved and one of the track hoes was moved to Frontier Park to move dirt to the left angle of the ditch to try to remove water and flooding from the Mills Creek area.

C. Engineer: Engineer Rodriguez stated all full depth projects are mostly complete but have been delayed due to rain. Traffic striping and crack sealing are in the same boat with all of the rain.

D. Auditor: No report.

E. Other Reports: President DeVries stated Council received the October 2020 Parks and Recreation Director's Report, the September 2020 Mayor's Court Reports and the September 2020 Police Department Report.

One of the conditions of the grant was that if it was not funded, there would be a requirement to reapply but at no cost.
